Exhibit Set-Up: Tuesday May 6th from 2:00 P.M. – 6:00 P.M.

Exhibit Breakdown: Thursday May 8th 10:30 A.M. - Exhibits must be clear by 2:00 P.M.

Exhibit Booth Details: The entire exhibit hall is carpeted. All Booths are 10 x 10 and come with one 6 ft. skirted table, 2 chairs, booth ID sign & wastebasket. Each booth consists of 8' high back wall and 3' high side rails.

Exhibit Location: GRWA will assign all booth spaces once the exhibit hall is sold out. The exhibit hall usually sales out in 2 – 3 days. The exhibit registration form includes a section where you can specify your preferred option of what companies you wish to be **Next To** or **Not Next To**. We try our best to accommodate everyone's preference. Once the exhibit hall is full, we will email the exhibit list to all exhibitors for a final review and another chance for exhibitors to specify their preference.

Exhibit Booth numbers will be available the first week of April.

Booth Extras & Shipping: PRX Exposition Services is the official general service contractor for GRWA Conference. PRX provides a way for you to place a secure, online order for additional booth furnishings or material handling services via an online exhibitor service kit. If you are interested in additional booth furnishings or advanced warehouse information, you will need to request access to the PRX Exhibitor portal by sending an email to Rebecca Wolfe rwolfe@preposition.com with your **Company Name, Booth #, First and Last Name, and Email Address**. ***GRWA will have your Booth # available the first week of April.***

All advanced shipments should be sent to the PRX advanced warehouse for arrival between Monday, April 7th through Thursday, May 1st, 2025. All exhibit material received will be delivered to individual booth spaces prior to exhibitor set up on Tuesday, May 6th. All outbound shipments following the close of the conference should be scheduled for pick up directly from the Jekyll Island Convention Center on **Thursday, May 8th between 11:00 am and 5:00 pm**. Any shipments not picked up may be subject to additional fees if left onsite.

Note: The Jekyll Island Convention Center will not accept any advanced shipments of exhibit related materials delivered to the facility. No exceptions. Direct shipments to the Convention Center must be permitted to arrive on May 6th ONLY. Jekyll Island Convention Center – 75 Beachview Dr. North Jekyll Island, GA 31527.
